#### It Wasn't About Alcohol

I've known since I first became aware of life around me that I was different, but I had no idea what it was. Being one of six siblings, it was easy to hide under the heap, so no one would notice me or my differences. That terrible feeling of tenseness followed me around everywhere. I didn't know the name of that feeling was "fear." You might think with so many kids that I'd have some idea of how to be social; not so with me. I was shy and introverted, awkward, and just a weird kid. Square peg; round hole. You get the picture. My sister was the social butterfly. I so envied her ability to meet new people and fit in. I felt so lonely even in a roomful of family, and there was ALWAYS a roomful of family.

My first drink of alcohol at age 13 removed that skin-crawling feeling for a short time. I was at a party with other kids around my age on the golf course one summer night, and I thought I would gag on the taste of beer. It was horrible! I wanted to fit in so badly that I kept drinking, or, should I say, choking down, that beer. I wanted to see what would happen, if the effect would be as good for me as for the people around me. After 15 or 20 minutes, I began to feel euphoric. I couldn't believe it. I felt free and happy! I lost my self-consciousness, and the tension I had felt for my entire life went away. Well, for at least 20 minutes while the alcohol worked its magic on me. The moon was brighter, the people with me were my friends, and I finally felt like I fit in somewhere. I forced down another beer, and the feeling increased. These people were so funny! I hadn't laughed like that in forever! And then I had a reaction to the alcohol in my system. I was so nauseous; I couldn't stand it. Two beers were enough to give me the best feeling I ever had, and then I felt like I had drunk poison. I swore I would never do that again! Famous last words.

Of course, I did it again. I'm an alcoholic. Fast forward 8 years: I'm 21, ...

#### IT WASN'T ABOUT ALCOHOL (continued ...)

... drinking more frequently, and still getting sick from the alcohol. The feeling of alienation from my fellow humans and episodes of full-blown anxiety had grown over those years, and I had few connections with people. All I could see was my own suffering, not anyone else's. I felt like a child in an adult's body. I think of myself as a reasonably smart human being, but in this instance, I have a major blind spot. I could not see that alcohol was already my master. I always wanted to try a different way to drink so I could escape my feelings, and not get sick: no more of that stuff, try this drink, don't eat on an empty stomach ... No matter what I tried, I always got sick from it, but I wasn't willing to give up the release that I got from my cares for those few minutes after the alcohol took effect. As I look at it from this side of my life, it sounds crazy to me that I couldn't recognize that.

Did I mention that both of my parents, several step parents, and all four of my brothers either are or were in A.A.? I grew up in an alcoholic circus, and yet, one by one, my family started getting sober.

My moment of truth came when my mother got drunk again. She had been in A.A. since I was three, but she couldn't seem to stay sober. Here she was, in her mid-40s, drunk again, standing in the middle of the living room, and complaining that it was everyone else's fault why her life was so bad. Even I could see, as blind and self-absorbed as I was, that she had SOMETHING to do with her problems. I listened to her, and all I could see was myself. I behaved just like her. All the problems in my life were someone else's fault, not mine. I played the classic victim, just as she did.

My dad had been sober for 15 years at that point, so I asked him if alcoholism could be my problem. I think he must have danced a jig (in his mind, not in front of me) at the question. He had probably been waiting for years for me to ask for help. He introduced me to his friend, Barbara, who's first question was: "Do you have a problem with alcohol?" I had no idea. I was 21, inexperienced at everything and unsure of who or what I was. I had never had a blackout and only one hangover in my life. I had never lost a job, crashed a car, or had a DWI. She said, "Don't worry about it; try 90 meetings in 90 days, and, if you feel like this isn't for you, you can always leave, and your misery will be cheerfully refunded." And that was the start of my spiritual recovery. I never noticed an obsession with alcohol, even though I kept trying to drink "right." Alcohol certainly had its hooks into me, but giving it up was nothing to me. The unmanageability in my life (really, in my mind) was so clear to me that I got the second half of the first step right away ("... that our lives had become unmanageable.")

Since then, I've gone through the steps with Barbara and had an awakening of my spirit, which had been dying until I came to A.A. I see life in such a different way than I did right up until that first A.A. meeting. I continue to work the steps, sponsor people, have a sponsor, do service for A.A. at every opportunity, and do my best to enlarge my spiritual life. The self-absorption and fear that plagued me before I got into the program still occasionally bother me, but they don't cripple me anymore. I have the freedom I was trying to find with alcohol without the side effects!



## **About Concept 1**


This responsibility was transferred to our entire Fellowship on behalf of Dr. Bob by Bill W. at the St. Louis International Convention in 1955. Until then overall services were the sole function of a few old-time A.A.s, several nonalcoholic friends, Doctor Bob and Bill W. For all the years of A.A. infancy, the old timers had been the self-appointed trustees of Alcoholics Anonymous.

There were several reasons for this shift of ultimate responsibility and authority to A.A. as a whole. In 1948 it became known that Dr. Bob was suffering from a fatal illness. The founders faced the fact that they were perishable. Another reason for the shift centered around Tradition Two, which declares, "For our group purpose there is but one ultimate authority – a loving God as he many express Himself in our group conscience. Our leaders are but trusted servants; they do not govern."

Alcoholics Anonymous has been called an upsidedown organization because the ultimate responsibility and final authority for world services resides with the groups rather than the trustees, the General Service Board or General Service Office.

## The First Tradition

Our common welfare should come first; personal recovery depends upon A.A. unity.



## Step 1

We admitted we were powerless over alcohol, that our lives had become unmanageable.

## **Tradition 1 (Short Form)**

Our common welfare should come first; personal recovery depends upon A.A. unity.

## Tradition 1 (Long Form)

Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.

## Concept 1

The final responsibility and ultimate authority for A.A. world services should always reside in the conscience of our whole Fellowship.
