STEP 6



Becoming Powerless

Hi everyone, my name is Peggy, and I am an alcoholic.

I remember my first buzzed drinking because it had such an impact on my life for the next 17 years. I was 13 years old and over at my cousin's house. I loved it over there because her parents did not have the strict rules that mine did. My aunt and uncle had had a party where we snuck out a few beers and drank them in the basement. They tasted horrible, but we both finished what we had taken. Afterwards I went to the bathroom to look at myself in the mirror because I knew something wonderful had happened. I now realized that I was worthwhile: I was beautiful; I was charming and very funny. I was enough! Up until that moment I had always thought that there was something a bit off about me. I didn't match up to what I was supposed to be (I secretly thought I was an alien.) But those beers!!! They opened up a whole new door of fitting in, self-confidence, and most of all: self-approval.

There is no need to go into detail about the next seventeen years; just know that I chased after that elusive feeling of being "good enough". At first, I thought it would happen at 3 drinks; no. Maybe 5 drinks; no. Maybe 10 drinks; nope. And so on and so on. I could never seem to reach that wondrous state of mind, but I pursued it with a vengeance.

Fast forward – I'm 30 years old; drinking every day and never finding that peace of mind and wanting to end my life. My misery is complete. I have placed myself in a dark dungeon of total hopelessness. I hate God so much and think he is here to laugh at my failure as a human being.

My plan for suicide ended up getting me help. A therapist quickly saw my drinking was more than a little problem. She challenged me to only drink two drinks per day. I thought this would be so easy — until I tried it. No matter how I tried to control my intake, once I started drinking, I could not stop. IT WAS MADDENING!!! This agony went on for a few months until one day the first step rang out in my head. "I am powerless over alcohol and my life is unmanageable." NOOOO, oh the deep despair I (Continued on page 2 ...)

experienced at that moment. I really thought all the fun and joy were done with in my life.

With a heavy and belligerent heart, I started to attend AA meetings. I remember looking at those 12 steps and rejecting both step 2 and step 3 right away. For the next 2 and 1/2 years I went to AA meetings and did not drink, but I followed none of the suggestions (90 meetings in 90 days, sponsorship, home group, step work...) I tried it on my own and lived a life of rage and discontent. People kept trying to get me to open up and become willing to bring spirituality into my life, but I was stubborn (and stupid.) Suicidal thoughts dogged my every step. One friend in AA kept telling me to "get a God of my own understanding, not the God of my youth." And one day the miracle happened!! I looked to the skies, opened my heart, and asked a Higher Power to enter my life. Immediately I felt such a feeling of peace and joy. All of a sudden, I realized that I was worthwhile, beautiful, funny, charming, and enough! As a matter of fact, I was more than enough. All thoughts of suicide ended right there and never came back.

This spiritual awakening allowed me to finish steps 2 and 3 then and there. I was now ready to being working on the rest of the steps and went out to find a sponsor. My new loving God led me to a woman who needed me just as much as I needed her. She led me through the rest of the 12 steps and I thank God for her guidance and kind heart. Life today is not perfect, but I now have a loving God who brings me joy, laughter, friendships, and moments of true serenity. On bad days, no matter how far down I let myself go, God is always there with me to bring me back with love.

So, if I have any words to share with you, dear reader, it is to STAY with the program until the miracle happens. If you want to do this with a minimum of pain: get a sponsor, find a home group that makes you comfortable, work the steps, and find a Higher Power that loves you!

DCM Corner

When I was new to A.A., I was a broken person. I had no self-esteem, no self-worth and I felt I didn't deserve it. The things I did while drinking were shameful, humiliating, self-destructive, and deceitful. I didn't know who I was. I had always been somebody's wife or mother, but divorce and my children growing into adults changed that.

The suggestions that were given to me in the beginning of my journey in A.A. were: go to 90 meetings in 90 days, get a sponsor, get a homegroup, take a commitment, call 3 alcoholics that are not your sponsor, call your sponsor, read the Big Book, take the 12 steps with the guidance of your sponsor, and read A.A. literature daily. Men with the men, and women with the women, and don't get into any relationships in the first year.

The last one seemed odd to me at first, but these people who were in my homegroup had a lot of years of sobriety and they knew what they were talking about. They were so right. I took all of their suggestions. While working and practicing the principles of the 12 steps, I learned who I was. Some of me I didn't like and some of me was not so bad. I

found while working my 4th step that I was fearful of a lot of things but most of all being alone and that no one could love me.

It wasn't until I had completed the 12 steps that I realized that I am a person worth loving. I had gotten my self-respect back. I was able to forgive myself of the wrongs I had done and forgive those who I thought had wronged me. Today I have dignity and self-love. I don't fear being alone because I know I'm not alone as long as I stay connected to the God of my own understanding and the fellowship of Alcoholics Anonymous. I love who I see in the mirror everyday now.

I think those people were right about not having a relationship in the first year. Back then when I was so broken, if I had gotten into a relationship, I would have not found me. I would not know the things I know about myself now. I would not have been able to change. My biggest change is that I no longer need to fear being alone and that I am lovable.

About Concept 6

We have seen that the "final responsibility and ultimate authority" for A.A.'s service activities rest with the A.A. groups (Concept I), but to carry out this responsibility they must delegate to the Conference (Concept II). The Conference, in turn, must delegate administrative authority to the General Service Board of Trustees. Again, it is helpful if you are familiar with both the Conference Charter and the Bylaws of the General Service Board to understand this relationship and the freedom of action that the trustees must have.

The trustees have the legal and practical responsibility for the operation of A.A. World Services, Inc. (which embraces A.A. publishing as well as the General Service Office) and of the A.A. Grapevine, Inc. These entities have a combined cash flow of many millions of dollars annually. The trustees are also responsible for A.A.'s public information activities. They are the guardians of the Twelve Traditions. They are responsible for carrying the A.A. message to other countries around the world. They are A.A.'s "bankers," overseeing the financial operations and investing A.A.'s substantial Reserve Fund. (Read the text of Concept XI for a more detailed account of their functions.)

Bill makes the point that although "our objective is always a spiritual one," nevertheless our world service is a "large business operation." "Indeed," he says, "our whole service structure resembles that of a large corporation. The A.A. groups are the stockholders, the delegates represent them, like proxy-holders, at the annual meeting; the General Service Board Trustees are actually the directors of a 'holding company.' And this holding company (the General Service Board) actually owns and controls the two 'subsidiaries' (A.A.W.S and the A.A. Grapevine) which carry on the ... services.

"This very real analogy makes it ... clear that, like any other board of directors, our trustees must be given large powers if they are to manage the ... affairs of Alcoholics Anonymous."

Step 6

Were entirely ready to have God remove all our defects of character.

Tradition 6 (Short Form)

An A.A. group ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose.

Tradition 6 (Long Form)

Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to AA should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management about be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A. -- and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.

Concept 6

The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.




