Nowhere To Hide

My name is Andrew W., and I am definitely an alcoholic. My sobriety date is 10-20-2023, and, at the time of writing this, I have been sober for about four months. I am 43 years old and was born and raised in upstate NY. I was a very rebellious kid, and even at a young age I had already developed some nasty character defects. I became spiteful, self-centered, and grew an ego the size of Texas which remain the same character defects I still fight today. Five months ago, I would have painted you a picture of how I grew up in multiple homes and had divorced parents. My ex-wife left me and took my kid away. I had all of these reasons for why I developed such strong resentments and defects. Alas, the last four months have seen the greatest change in my life, my heart, my daily routine, and even the way I think — and so I have a very different way of looking back upon my past than I did five months ago.

Aside from getting kicked out of schools, running away, and doing stupid crap to get attention, I discovered at a very early age that there was this magical substance called alcohol that could numb my pain and make me feel happy with myself. This of course was a lie, but at the time I thought it was the greatest thing ever. I skipped the part where kids experiment with alcohol and drink it on social occasions, and I went directly to hiding it in my closet and drinking in secret. I would often augment with weed, pills, and other substances as well, but alcohol was always the easiest to get because everybody in my family and friends' families drank. We never had a problem getting our hands on it as kids.

From my teens to my forties, a lot happened. I got married, divorced, and had a kid. I joined the navy and did a tour overseas. I lived in multiple states and ultimately decided to adopt a life on the road as a full time RVer. Looking back at it all now (and especially this whacky idea to go live life in an RV), I realize it was always just me running from my problems and chasing that magical feeling of happiness and serenity. This became increasingly impossible to reach as I progressed in my drinking career. I left a lot of damage in my rearview mirror; choosing this life style was conducive to my drinking. I had, without realizing it, changed every single aspect of my life to center around my drinking. I was developing extreme anxiety and depressive disorder, so I gave up all other substances and doubled down on my alcohol because I still didn't ...

... see it as a problem in my life but a solution. My daughter wouldn't talk to me, and my friends ignored me. It's funny how everyone I knew seemed to go to bed at about 7:00 pm because they wouldn't answer the phone when I called.

Last fall, I took the trip back down south in my camper and stopped a while in Tennessee. I knew I needed to change something. At the time, I was debating moving to Tennessee. I thought I loved it there, but what I loved was the idea that something needed to change. I had a couple of last hurrahs drinking my face off at some music concerts, but my anxiety was through the roof, and my blood pressure and heart rate were getting critical. I couldn't enjoy myself. It was a constant effort to ride the knife edge of drinking just enough to be drunk but sober enough to avoid a panic attack. I realized drinking was no longer an activity but a requirement for me. The last weekend I spent at a huge rave in a cave and used up all my battery power in the camper. I was the last camper to pull out having woken up about noon, tripping over beer bottles and whatever else was on the floor. I threw everything in the camper. I was dirty, screwed up, and hung over. I took off with the pets to go to Florida. It was only 900 miles, and I could do that in a day, so off I went.

Just over the border into Georgia, I had a wheel bearing blow out. By now my anxiety was so high I couldn't think straight. I managed to limp to a Walmart for the night and sleep. The next morning, I had to leave the camper there and backtrack 100 miles in the wrong direction to get the parts I needed to fix the wheel bearing. I spent the whole day in that Walmart parking lot working on it. The batteries were dead, so there was no air conditioning. Have you ever seen a cat panting like a dog, sweating, sprawled out on the floor dying of thirst? It freaking broke my heart. At that moment I had had enough. I broke down crying and started praying. I asked my God to help me. I couldn't live this way any longer. I knew about AA because my grandfather had been a 29-year member and had just passed this last year. He would often listen to me when I called and was never judgmental. He even took me to a few meetings as an observer, and he gave me his personal big book. Sadly, just before he died, I had given it back to him and said AA just wasn't for me. Well, I like to think of Gramps as my second sponsor these days because I got that book back. I get to read his notes in the margin and hear his wisdom. I can see now that what he did all those years was to plant the seed. He knew one day I would reach my bottom and need AA, and he made sure I had just what I needed to get me there. He lived by example, was humble, and happy, joyous, and free. At that time, he was gone, but I was finally ready to listen to him. The rest of the trip back my wheels stayed on, and traffic was light. I didn't have many more problems, but I drove the entire remaining distance deep in prayer and meditation. I decided, when I get there, I'm throwing out all my beer in the camper, all the liquor bottles, all of it. And I am finding a meeting. What I didn't know - what I couldn't have known at that time - is I basically completed steps 1 through 3 on that drive home, and it changed my life. I did exactly that. I threw out all my alcohol, and I found a meeting that was open, big book, in person and zoom. I figured I'd sit in the back or just hang out online and not really be a speaker or part of anything, just hide out in the shadows. That meeting was the Ridge Manor Big Book meeting on Tuesday nights. I walked in there, and when they asked if there was anyone attending their first meeting, what I could not have possibly ...

His alcoholic problem was so complex, and his depression so great, that we felt his only hope would be through what we then called "moral psychology," and we doubted if even that would have any effect. However, he did become "sold" on the ideas contained in this book. He has not had a drink for more than three years. I see him now and then and he is as fine a specimen of manhood as one could wish to meet ... I earnestly advise every alcoholic to read this book through, and though perhaps he came to scoff, he may remain to pray.

But my friend sat before me, and he made the point-blank declaration that God had done for him what he could not do for himself. His human will had failed. Doctors had pronounced him incurable. Society was about to lock him up. Like myself, he had admitted complete defeat. Then he had, in effect, been raised from the dead, suddenly taken from the scrap heap to a level of life better than the best he had ever known.

Had this power originated in him? Obviously, it had not. There had been no more power in him than there was in me at that minute; and this was none at all. That floored me. It began to look as though religious people were right after all. Here was something at work in a human heart which had done the impossible. My ideas about miracles were drastically revised right then. Never mind the musty past; here sat a miracle directly across the kitchen table. He shouted great tidings. I saw that my friend was much more than *inwardly reorganized*. He was on a different footing. His roots grasped a new soil.

... known just before raising my hand was that those people, that group, and this way of life would immediately and drastically infiltrate and change every single aspect of my life. What I also could not have known is just how grateful I would be for this huge life change.

It's only been four months, but I could not possibly articulate how amazing this transformation has been in my little world. I have a sponsor, and he helped me work the steps. I go to meetings almost every night between Lake Pan, Bushnell, Ridge Manor. I have met so many incredible people in these rooms. Of course, the biggest thank you belongs to my Higher Power. He brought me to this place, and He listens to my daily prayers to remove my character defects, to remove my addictions, and to give me direction and purpose in helping other people.

My purpose each day now is to be kind and helpful and to practice these principles in ALL of my affairs, whether I let that car enter my lane of traffic, or hold the door open for an old lady at Walmart. My entire life is made new. I finally found that all-time high I had been looking for, but it wasn't at the bottom of a bottle, nor was it just over the next horizon on the highway in my camper. It was here all along. My grandfather knew that, but he also knew I would have to find it out on my own. Thank you all for keeping me sober — and for giving me purpose.





The district is also looking for an interim alternate DCM at this time. Many thanks to Lori Ann S. for her time in service. A minimum of four years is required for this position. Please attend the district meeting where you will be asked to provide your service resume. If more than one person stands for the position, the GSRs will then vote.

Another position which is available is PI/CPC, also known as Public Information/Cooperation with the Professional Community Committee. Members of PI/CPC committees across the nations inform the public, professionals, and future professional (such as

Also available is the position of Archivist. An archivist for Alcoholics Anonymous (A.A.) collects, organizes, and preserves historical records. They are responsible for the physical and intellectual integrity of the collection. No experience is necessary, but some sobriety is required.


Hello District 13!!

Changes to Intergroup Bylaws

Addition of Parliamentarian Position to Hernando County Intergroup

Purpose: The Parliamentarian is a member who has been appointed by the Intergroup Chair who provides advice or counsel on matters of parliamentary procedure. Parliamentarian is an appointed position by the Intergroup Chair. This services position will not exceed 2 years, in the spirit of rotation.

Description: The parliamentarian sits adjacent to the chair and unobtrusively gives the chair help, guidance, and support during the meeting. The chair can and should consult with the parliamentarian when not certain on how to rule on a question or proceed in the circumstances. A parliamentarian is an expert in interpreting and applying the "Rules of Order" for meetings. These rules, such as Robert's Rules of Order, enable groups to efficiently and fairly discuss and determine actions to be taken. The Parliamentarian does not rule.

Change of Title to Intergroup Assistant Office Manager

Motion: Change Title of Intergroup Assistant Office Manager to Co-Manager.


