A Path To Serenity

My story is garden variety: I was hopeless, self-seeking, and finally, spiritually bankrupt enough to reach a point of desperation where I was willing to do anything. That's where AA and a Higher Power of my understanding came in for me.

I grew up in a smallish town in Massachusetts, always feeling different, less than and apart from. I thought our household was normal. My parents both worked 9-5 and partied on the weekends. Friends and cousins would come over, many times crashing for the night. This was an average weekend for us, and I loved it. I was a pretty good kid growing up, quiet, and kept to myself.

When my sister was born, I was 6, and things got tough. I had to grow up quickly as she had special needs like autism and epilepsy that weren't well known in 1997. There were lots of hospital trips and stress. The household was tense, and it was important to me that I fly under the radar and not make a fuss; my parents had enough going on. Nobody ever told me that I was a burden, but I always felt like it. I learned in AA that that may have had something to do with being an egomaniac with an inferiority complex.

We moved frequently, and I loved it because I could attempt to be someone brand new, all shiny. Unfortunately, I learned that early on, wherever I moved, there I was. My internal monologue was always running, fueled by fear. My fear of pretty much everything caused me to form these assumptions based on self that further dictated how I behaved, how I spoke, what I wore, etc. What I portrayed on the outside was what I thought I was supposed to be. It was all based on lies.

I believe I was an alcoholic long before I took my first drink. Once I finally did take that first drink at around 15, all of those fears washed away. I was a blackout drinker from the get go, and I was immediately willing to do whatever it took to get the next drink and to not feel what I was feeling. Drinking was the answer to all my problems. All of the terrible things that had happened to me were drowned out. I didn't have to relive and replay them anymore. The sexual abuse I had experienced at a young age had completely defined who I was, or so I thought. I assumed the role of victim, and everything that came along with it. Because wouldn't you want to drink it all away ...

... if it happened to you?

As the drinking progressed so did my ability to rationalize and justify my behavior. I got a pass on a lot of things due to my history, which I fully took advantage of. Getting through the end of high school was challenging, but I finally did it, and after that, all I wanted to do was get away. Another failed attempt of becoming a new version of me.

My next venture was in Chattanooga, TN. I knew no one, except for the boy I met on the internet. It was perfect. I could be anyone I wanted. I had worked in the restaurant business since I was 16, so I was able to get a job at a pizza place down town. That's where I met my next hostage, because the latest one had already had enough of me 2 weeks in, so I needed to start making arrangements. I went over to his place, which was in the basement of his parents' house, and that was it. It was a match made in heaven. He drank the way I wanted to and didn't say anything about my drinking. I soon moved in and we continued working in restaurants and then going to either a bar or home and drinking until we passed out; lather, rinse, and repeat. That was the cycle of my drinking for the next several years.

Again and again, I chose drink over relationships, jobs, and having a future. I forfeited everything, willingly. I was not living, but merely existing. During the peak of my drinking, I became pregnant and had a child. I'm grateful to say that by the grace of God I delivered her healthy and without having used or drunk during the pregnancy. After her birth, I went right back to what I was doing like I never stopped. The progression took over. What little control I thought I had was gone; alcohol was everything. Jobs were lost, apartments were lost, I was empty. I had arrived at what I know now is the jumping off point. I couldn't imagine a life with or without alcohol.

I had a friend in another 12-step program that could see I needed help, and she gently suggested that I tag along with her to a meeting, but I politely declined. I wasn't ready to give it up, until the pain became great enough. She shared something with me: nothing changes if nothing changes. I couldn't get that phrase out of my head, until finally I called her and asked her if I could go with her, and she obliged. I went to several of those meetings and soon went my own way.

I ended up in AA, and I was really nervous. I thought it was going to be a bunch of creepy old guys. My very first meeting was bright and early at a tiny church on the very first street I had lived on when I moved to Chattanooga. I actually had to walk by it to get to my bus to get to work. The meeting was very small, just myself and two older gentleman and they were exactly what I needed at the time. They offered me coffee and cookies, but I couldn't move. It took about all I had in me to get through the door and into a chair. I was frozen in fear and only a couple weeks without any substances at that point. Those gentlemen were the first examples of AA for me, and they shared their stories with me.

For the first time in my life, I felt like I belonged. This what was I had been searching for all my life. My whole life I felt like I was waiting for my real family, and here they were. I kept coming back, because that's what was suggested to me. I was encouraged to go to literature meetings, offer to help clean up, stay after the meeting and introduce myself, arrive early and introduce myself, even though it was absolutely terrifying. Eventually the fear faded, and I got to know people. I got a sponsor and then I got a different sponsor which I learned was okay too. I ...

Promises #6 pg. 13

My friend **promised** when these things were done, I would enter upon a new relationship with my Creator; that I would have the elements of a way of living which answered **all my problems**. Belief in the power of God, plus enough willingness, honesty and humility to establish and maintain the new order of things, were the essential requirements. Simple, but not easy; a price had to be paid. It meant destruction of self-centeredness. I must turn in all things to the Father of Light who presides over us all. These were revolutionary and drastic proposals, but the moment I fully accepted them, the effect was electric. There was a sense of victory, followed by such a peace and serenity as I had never known. There was utter confidence. I felt lifted up, as though the great clean wind of a mountain top blew through and through. God comes to most men gradually, but His impact on me was sudden and profound.

Promise #7 pg. 15

I was not too well at the time, and was plagued by waves of self-pity and resentment. This sometimes nearly drove me back to drink, but many times I have gone to my old hospital in despair. On talking to a man there, I would be amazingly lifted up and set on my feet. It is a **design for living that works in rough going**.

Promise #8 pg. 15

We commenced to make many fast friends, and a fellowship has grown up among us of which it is a wonderful thing to feel a part. The **joy of living** we really have, even under pressure and difficulty. I have seen hundreds of families set their feet in the path that really goes somewhere; have seen the most impossible domestic situations righted; feuds and bitterness of all sorts wiped out. I have seen men come out of asylums and resume a vital place in the lives of their families and communities. Business and professional men have regained their standing. There is scarcely any form of trouble and misery which has not been **overcome among us**.



Step 4

Made a searching and fearless moral inventory of ourselves.

Tradition 4 (Short Form)

Each group should be autonomous except in matters affecting other groups or A.A. as a whole.

Tradition 4 (Long Form)

Our membership ought to include all who suffer from alcoholism. Hence, we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.

... went through the steps, even the scary ones, and I found out that I wasn't alone in my secrets either. My sponsor shared some of her experiences as I shared mine. I made amends wherever possible, except when to do so would injure them or others. I lived the steps, I had a home group, and commitments. Everything was great until I couldn't move forward in my relationship.

My daughter's father did not want to quit drinking, and I couldn't stay. I was told no major changes for the first year, so I gave it 11 months. That's when I moved to Homosassa, Florida. My grandparents had retired here years ago, and slowly other family members trickled down. By the time I made it, there was my grandmother, my mother, and my sister. I brought my daughter with me, and, for the first time, I moved, and my first thought wasn't "who can I be?" My first thought was figuring out how and when was I going to get AA in Citrus County.

I went to a meeting the very next day and dove right back in, got a literature meeting as a home group, and a sponsor. I got a job and was able to start saving money. My grandmother, who was always my most favorite person, had beaten breast cancer, but it came back, and the cancer metastasized in her brain. She was rushed into surgery, but there was nothing they could do. She never recovered and was on life support. My family and I had to make an impossible decision, yet I was able to walk through it sober.

AA taught me how to stand up, and hold others up with me. I stayed single for a period of time which was an

accomplishment in itself because I was a serial monogamist, or hostage collector. Working on my character, my program, and keeping my daughter safe was, and remains, my top priority. I enrolled in school in Spring Hill, FL, and graduated with honors. I still work in the field in which I obtained my education.

I met a great person, and we've been building an incredible life together since April of 2018. We have a blended family which has its own challenges. I get to choose us every day, because I had the freedom of choice returned to me when God removed the obsession to drink.

My home group is the Aripeka Big Book Study, Thursday nights at 7:00 PM on Kass circle; feel free to join us. I have a sponsor, who has a sponsor, and I sponsor others. I never thought the promises would come true for me, and here I am, living proof. I was led here and remain here because of the examples of this program before me.

I know that if I remember I'm a person that I'm responsible for, and that my gift from God is just that, a gift, that I continue to care for I'll be ok. I'm a work in progress, and I'm okay with that today. Awareness is a gift, and the ability to inventory is a gift. I want to be better today, instead of just wanting to want. I no longer regret the past nor wish to shut the door on it, and I'm so grateful that I have a place to come where I can just be Sam, the alcoholic.

DCM Corner

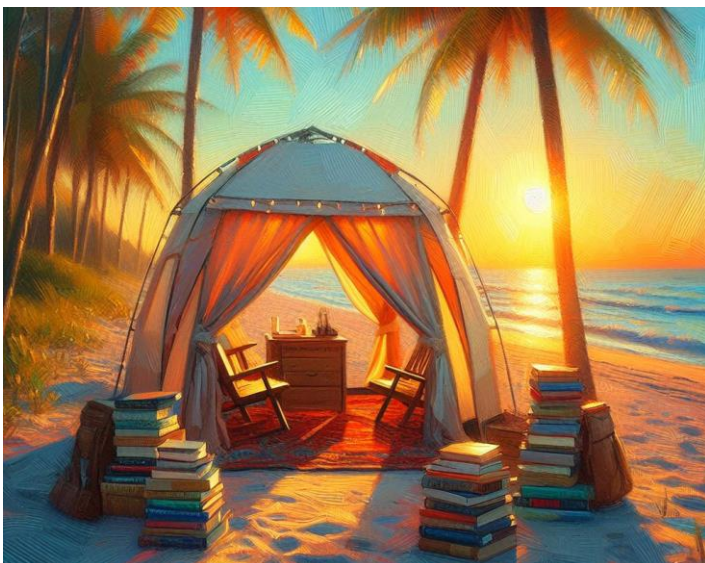

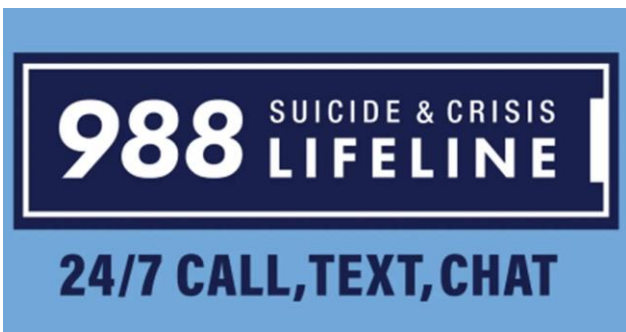
Meeting In A Box

- Lack of Transportation/Mobility
- Childcare Availability

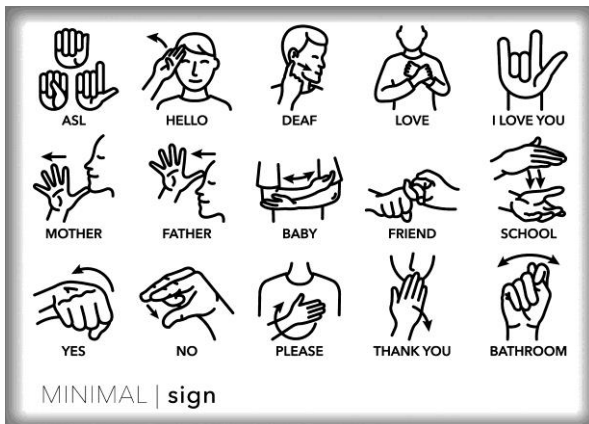

Another position which is available is PI/CPC, also known as Public Information/Cooperation with the Professional Community Committee. Members of PI/CPC committees across the nation inform the

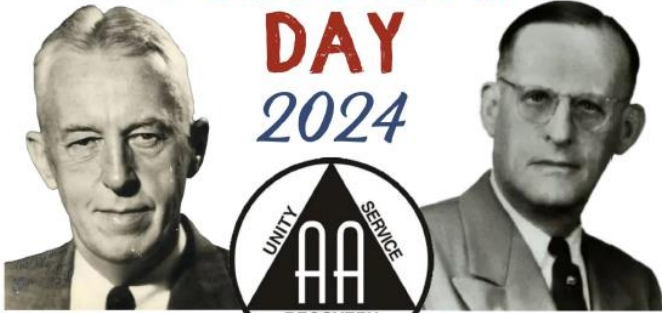

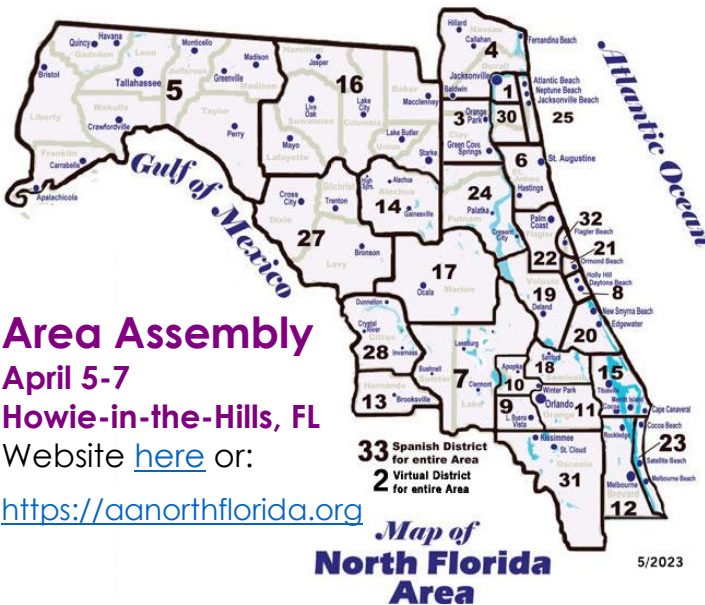
