There Is A Solution

I grew up in Brooksville. My childhood was not that bad. I have a sister and two half siblings, a brother and a sister. My half-brother is no longer with us due to this disease. Today I have a relationship with my half-sister thanks to the program of Alcoholics Anonymous.

Growing up was difficult at times for me. I got bullied and picked on in middle school. My parents split up when I was pretty young. I always tried to fit in and felt like I never did, like trying to fit a square peg in a round hole.

My parents have been in the program since I was an infant. I would go to meetings as a child with them if nobody could watch me. I started drinking when I was about 15, and it made me feel taller, better looking, and bulletproof.

I got a DUI when I was 18, and that's when I started my A.A. journey. I was not a "one chip wonder." I continued to drink and continued to get arrested, wreck vehicles, and lose my license. I was emotionally and mentally bankrupt.

I thought growing up in the rooms had helped me, but it only hurt me. I could talk the AA talk and could say the right stuff to people, but I could never walk the walk. I would get little bouts of sobriety here and there to get my parents and judges off my back. However, I could never stay sober for any amount of time. I also couldn't keep a job. Day after day, I woke up, and I just wanted to die. I resented God for waking me up. I was in a really bad state of mind and body. I was sick; I knew there was only one solution for me, and that was AA.

After 15 years of being in and out of the program, hopeless and lost and desperate, I came back to AA on May 4th, 2020. A Power greater than myself has helped me stay sober.

This year, I will celebrate four years of continuous sobriety. I have worked the steps with a very patient, yet straight forward sponsor. Throughout these four years I have all of my kids back at least fifty percent of the time, and I have a great relationship with my parents and with people in the rooms. I have a beautiful and loving wife who is by my side. I'm a successful business owner. I just want to help at least one ...

District Service Positions: In Depth

Here's a more comprehensive look at the service positions available for District 13, taken from the A.A. Service Manual and District 13 Structures and Guidelines.

Alternate DCM (pg. S33):

The Alternate DCM assists and participates in District responsibilities and should be prepared to serve as DCM if the DCM is unable to fulfill his/her responsibilities. It is suggested elections be held every two years and that GSRs, the alternate DCM and the DCM serve their terms concurrent with the Area Delegate. Experience of the Fellowship suggests that a[n] [Alternate] DCM ought to:

- Have served as a GSR
- Have at least four or five years of sobriety
- Be familiar with both the Twelve Traditions and Twelve Concepts
- Have the time and energy to serve the district well
- Be able to lead a district while respecting the conscience of the district
- Have an email address or other easy way of maintaining contact with GSRs and other members
- Be familiar with the G.S.O. and area websites

Some of the alternate DCM's Duties:

- The [alternate] DCM's job is primarily that of two-way communication.
- Regularly attends all district business meetings and area assemblies.
- Receives reports from the groups through GSRs and through frequent personal contacts with groups in the district.
- Assists the area delegate in obtaining group information in time to meet the deadline for AA directories.
- Keeps GSRs informed about Conference activities.
- Makes sure that GSRs are acquainted with The A.A. Service Manual, the Twelve Concepts for World Service, the GSO bulletin Box 4-5-9, workbooks and guidelines from GSO, and any other service events.
- Organizes workshops and/or sharing sessions on service activities.
- Regularly keeps in touch with the alternate DCM and the delegate; sends district minutes to the delegate and alternate, and exchanges them with other districts.
- Makes a regular practice of talking to groups (new and old) on the responsibilities of general service work

Secretary (pg. S45):

Suggested Qualifications:

- Generally, has approximately three (3) years of sobriety.
- Has skills to take accurate minutes and prepare these minutes in a publishable form in a timely manner.
- Able to organize a filing system for minutes and is prepared to research and find past procedures when asked.

Duties:

- Should have the time and skills to use a computer.
- Keeps accurate minutes of the monthly meetings and officers'
 meetings. Prepares these minutes and other materials as
 directed in a format to be sent to all positions listed on the
 district roster.

- District minutes will be distributed by the 20th of the month.
- Electronically records District meetings to use, when necessary, to transcribe the minutes.
- Submits a monthly copy of the final minutes to the Archivist.
- Updates and, when requested, provides a current list of district advisory actions.

Archives (Archivist):

This position will be elected by voting members of the district. The Archivist will serve for at least a two (2) year, but not to exceed a six (6) year term. This office does not have a vote at the district level.

Suggested qualifications for the Archivist position include:

- Familiarity with District history.
- Experience with archival and conservation procedures and an understanding of how to handle historical records.
- A good understanding of our primary purpose and AA Traditions, helping to ensure proper privacy and anonymity practices for members whose names appear in collected documents.
- The Archivist should be an AA member.

Duties of the position may include, but are not limited to:

- Preserving the documents and art factual items and maintaining the physical integrity of the collection.
- Collecting, organizing, and preserving material of historic interest to District 13.
- Maintaining contact with the Area Archivist to ensure integrity of the district archives inventory. The Area Archivist helps maintain and update District 13 Archives inventory and assists in accumulating historical material and information pertaining to the district.

If you are interested in any of these positions or have questions about them, please come to the district meeting which is held the first Monday of every month (May 6th this month) at 6:15 PM at 1214 Broad St, Masaryktown.



WILL YOU BE THERE?

As you may have noticed lately, there has been a drive for 12th Step call list volunteers. Over the last several months, the number of people who have stepped up and put their name on the list has been disappointing. It occurred to me recently at an intergroup meeting that many folks did not understand what was involved in being on the 12th Step call list.

Our hotline is answered during business hours at the Intergroup office by office volunteers. When the office closes, hotline calls are forwarded to hotline volunteers who receive the calls on their personal phones. When the Intergroup office re-opens, they take over the hotline calls again. This ensures that someone is available to answer that call 24 hours a day, 365 days a year.

I have been a hotline volunteer for about four years. I answer the hotline (from my personal cell phone) from 5PM Monday afternoon until 9AM Tuesday morning. On average I answer about six calls a month.

Most calls are for meeting times and locations. Occasionally someone is looking for help getting to a meeting. Sometimes a caller is looking for someone to talk to. I recently had a caller who wanted to get a Big Book after business hours, and I was able to facilitate that request by placing a few calls.

As a 12th Step call list volunteer, you specify the times you would likely be available to help if we call on you. You can specify if you would be willing to give someone a ride to a meeting, talk to someone on the phone, or possibly be of service in other ways. You are making no guarantees that you will be available, only that you are willing to be contacted. You will only be contacted by another Intergroup volunteer. Your number is NOT given out to callers. If you have agreed that you would be willing to help someone get to a meeting, we would call you and ask if you are available to facilitate that. If you are, then we give you the callers



contact info for you to reach out to them. Please keep in mind, we encourage men with men, women with women, and never go alone. If you are not available when called, a volunteer simply moves on to the next appropriate name on the call list.

Carrying the message is fundamental to our recovery and survival. My personal experience is that this commitment has not been too demanding, but has at times been significantly rewarding. I hope you might feel moved or inspired to become active in our fellowship.

Someone was there for you. Will you be there for another?






