#### Small Town A.A.

I am from the Midwest, born and raised in Missouri. Mom and dad divorced when I was young, and both remarried. My other two sisters and I were the stepchildren. It is what it is, and we survived, maybe in different ways.

I didn't start drinking until I was a teenager. It was always around the house, and the family drank, but I believe now that they all drank moderately. I don't remember any out of the ordinary situations, but I can't say I remember a lot either.

We moved to a small town in Montgomery City, MO when I was a sophomore in high school, and I starting hanging out with some of the girls and guys I got to know. It was a small town, and new people were definitely noticed when they moved there. I cannot remember exactly when my drinking took off, but I think it was maybe my sophomore or maybe even junior year.

When I got a hold of beer and then whiskey, well, it just changed my whole outlook on life, right then and there. I loved it from the very beginning. I didn't have to be Debbie anymore. I felt like I had been changed into someone who was wild and fun and having a great time. By the next morning, OMG, I am not sure what I felt like, but it wasn't good. It didn't last long enough because I was back to drinking the next opportunity I had.

Since that time, I was loving my alcohol except for the morning after. I did that for a very long time with friends at school. Our senior class was about 150 students; everybody knew everybody.

One night I came home drunk and went upstairs to my room. I had started smoking cigarettes at this point. In my drunken state, I went downstairs to go to the bathroom, and when I went back upstairs to my room, my bed was on fire. I had to get mom and dad, and they called the fire department. Grandma was up there with me, too. Needless to say, it didn't turn out well. We all survived and lived through that, but it was not a pretty picture for me.

I have had car accidents and was stopped by the cops, and I spent a couple of nights in jail on different occasions. It didn't stop me from drinking, though. Another incident I had was drinking downstairs while everyone was asleep. I got drunk, and I went in to the bathroom to turn on the bathtub. I went back to my chair to wait for it to fill up and passed out. When I woke up, the bathroom was flooded. I mopped and mopped and got everything looking pretty good. The next day, mom went down to the basement and couldn't ...

... understand how the basement had gotten so wet. Oops! I didn't even think of that, but that was not a pretty scene. I have had other situations which were not great either. I was an alcoholic, and those are some of the things I did because of drinking.

After graduation, I got a job and started living on my own, hanging out with my friends, got married, and then started a family. I had a daughter with my hometown man. I just loved drinking way too much. I got divorced, and then my drinking really took off. Some of the places I wound up at were not where you would take family. I got out on my own. I always seem to leave town when I broke up with a guy. That is my motto, you could say.

I moved back in with Mom in St. Louis with my daughter, and she helped watched Sara. I worked and saved up to get my own place. I was still drinking, and I cannot tell you how many times I went with friends and then wound up in not so good part of town. I never once worried about whether I would make it back alive or not. I am a very lucky woman.

It went like that for years until I got confronted by others that were worried about me. I tried cutting back, but it didn't last long. I think someone was looking out for me because some of the places I hung out at and some of the people I got to know was not your regular mom and pop people. I am so lucky that I didn't wind up raped, dead, or found along the side the road somewhere.

I finally moved back to Dad's, and a friend took to me an A.A> meeting right there in town. It is a small town, and I think there are a lot of alcoholics there because what else is there to do? I did start going to meetings, and it took a while for my head to clear enough that I realized how my life was actually looking to me. I would travel to other A.A. meetings around because there weren't many meetings nearby. I started getting out and about to other small towns, and, believe it or not, every small town had a place for an A.A. meeting somewhere. HUH!

Our A.A. meeting was right next to the bar on the corner. There was Crazy Joe, Cowboy Kenny, Crash, and me. That was it for the most part. I had lost my driver's license, of course, so Crash was nice enough to pick me up and take me to meetings. I did get a hardship license, so then I could drive to work. Things started getting better as long as I kept going to meetings. Finally, I was able to drive again and got out to more A.A. meetings.

I thought I was doing pretty good. I wasn't drinking. My first sponsor had me digging and planting flowers, but she never went over the big book with me. Eventually, I told her it wasn't working out. I left there. I kept going to my A.A. meetings, and then out of the blue, Mike (whom I seen at meetings) called and asked me out. We moved in together and have been together ever since. That is how I met Mike.

My whole life has changed since then, and I have been sober now for 22 years with A.A. meetings, a sponsor, and my Michael.

# **Tradition 9 (Long Form)**

Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principle newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.

Tradition Two (short form): "For our group purpose there is but one ultimate authority — a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern."

The spirit of rotation is considered vital to AA's life because it helps ensure that the fellowship's mission, vision, and goals are achieved and protected from misdirection, misrepresentation, and failures. It also helps to ensure that no one feels like they own any AA service positions, and that everyone has a chance to learn about the services provided.

It's that time of year again! Time to elect trusted servants in our fellowship. All will begin with electing a new panel for North Florida Area 14 Panel 75 on September 29, 2024 at area assembly. I would like to encourage all registered general service representatives (GSRs) to attend this election. This is where your group's voice is heard! If you would like to serve at this level, service resumes (a summary of your service in A.A. and any talents you bring to the fellowship) will be heard. There are certain qualifications for each position as outlined in our AA Service Manual that should be met. The positions that will be voting on are as follows: delegate, alternate delegate, chair, alternate chair, secretary, registrar, treasurer, and trustee at large.

In our district, we will elect our own trusted servants. Elections for the open positions are as follows: district committee member (DCM), alternate DCM, secretary, treasurer, and archivist. To stand for a position, certain qualifications as outlined in our AA Service Manual and District 13 Structures and Guidelines should be

#### Alone, Not Lonely

I met an elderly gent the other day, and we began talking, or, should I say, he began talking. Soon I knew his history, his family history, his children's history, and all of the problems in the world. He was alone and lonely.

I thank a Higher Power and Alcoholics Anonymous that I am not that way.

Once upon a time, a few decades ago, I was at my bottom, physically, mentally, and spiritually. I was very alone, no family, no friends, and alone inside of a mind that had no clue.

A Higher Power, whom I choose to call God, did for me what I could not do for myself. An acquaintance introduced me to a young lady that I found quite attractive. I asked her for a date and she said no, you drink too much. I said I would quit, and I did. It happened that she was a friend of Bill W. with 5 years of sobriety. She invited me to attend a meeting with her.

My first meeting taught me that quitting the drink is the easy part, and staying stopped is the hard part. The second lesson was "learn to listen, and listen to learn."

I often complained about why God allowed me to drink alcohol excessively for thirty years. With a clear mind while working the steps, I learned that God had delivered me many messages over the years. I just was not listening.

Prayer is asking your Higher Power for direction. Meditation is listening for the answer. I was taught to listen to the literature; to listen to those sharing their experience, strength and hope during the meeting; and to stop listening to the resident rodents constantly running around in my head.

Quiet the noisy mind.

Every thought is a prayer. For me, a loving Higher Power knows what I'm thinking. Most importantly I needed to learn to listen to the silence. Silence is God's opportunity to talk.

Once upon a time, many moons ago, I was in a very crowded bar, and yet, with all of those people around me, I was the loneliest person on this earth.

Today, the lesson is, with a Higher Power a constant in my life, I know that I am never alone, and, with the fellowship in my corner, I need never be lonely.

# A Historical Gift of Desperation Steps One and Two

A reading and reflection on the exchange of letters between Bill Wilson and the renowned 20th century psychoanalyst Carl G. Jung provided me with perspective on the critical importance of the first and second steps of A.A.'s 12-step program. The letters reveal the significant roles of C. G. Jung and Rowland Hazard in the establishment of those essential steps. Similarly important are the connections between Ebby Thacher, the Oxford Group, Dr. William D. Silkworth, and the principle of one drunk helping another.

C. G. Jung and Bill W. were familiar with each other's work with alcoholics. In 1961, Bill wrote to Dr. Jung regarding his treatment of Rowland Hazard's alcoholism in 1931 and his major influence on Alcoholics Anonymous. Rowland, a man of wealth and means, traveled to Switzerland in search of what he believed would be the solution to his nightmarish alcoholic condition.

Bill W.'s letter emphasizes the importance of Rowland's second visit with Dr. Jung. After completing his initial treatments, he believed himself cured. It was during Rowland's return visit, after traveling thousands of miles and spending considerable time and money on his recovery that he lamented his devastating "relapse into intoxication." During that visit, Dr. Jung honestly revealed the "hopelessness" of Rowland's alcoholism, "so far as any further medical or psychiatric treatment might be concerned." Bill wrote, "This candid and humble statement of yours was beyond doubt the first foundation stone upon which our Society has since been built.

Only then did Rowland acknowledge the unmanageability and powerlessness of his life (step one.) Faced with this devastating and undeniable reality, Rowland then asked if there was any other possible solution.

Dr. Jung then mentioned another possibility. Since psychiatry was still in its infancy and striving for recognition as a legitimate scientific discipline, he cautiously presented the only other possibility he could think of. The man of medicine and science suggested a "... spiritual or religious atmosphere, and hope for the best" (step two.)

Dr. Jung believed that the alcoholic's prevailing malady was rooted in an "unrecognized spiritual need." His letter concludes with, "... 'alcohol' in Latin is 'spiritus,' and you use the same word for the highest religious experience as well as for the most depraving poison. The helpful formula therefore is: 'spiritus contra spiritum'" ("spirit against spirit.")

Rowland recovered by becoming involved in a European spiritual movement known as the Oxford Group. The organization was a non-denominational movement focused on spiritual self-improvement. Their goal was a personal spiritual or religious experience without the constraints of formal religious dogma and theology (a Higher Power of their understanding.) While not directly addressing



alcoholism, their principles of self-survey, confession, restitution, and service to others became foundational elements for A.A.'s 12-step program.

Dr. Jung's letter outlines four "right and legitimate" ways to achieve a personal spiritual experience. He then acknowledged Rowland Hazard's search through "an act of grace" as, "under the circumstances, the best one."

Rowland returned to the United States and discovered that his friend, Ebby Thacher, was in danger of being legally institutionalized for his alcoholism and other offenses. Rowland effectively intervened and conveyed to him the medical and psychiatric hopelessness that alcoholics face and the spiritual solution — one alcoholic helping another.

After successfully recovering with the help of the Oxford group, Ebby, Bill Wilson's former schoolmate and drinking buddy, visited Bill's home after hearing about his alcoholic condition. This act of one drunk helping another inspired Bill to attend an Oxford group meeting out of curiosity and in search of Ebby.

Bill eventually left a note for his wife Lois and checked into Towns Hospital in Manhattan for his fourth attempt at sobriety under the care of Dr. William D. Silkworth.

When Ebby visited Bill at Towns Hospital, Bill asked, "What is your neat little formula once more?" Ebby answered, "You admit you are licked; you get honest with yourself; you talk it out with somebody else; you make restitution to the people you have harmed; you try to give of yourself without stint, with no demand for reward; and you pray to whatever God you think there is, even as an experiment."

Through love and friendship, Ebby became the final catalyst for Bill's recovery. On December 11, 1934, Dr. Silkworth's assessment of alcoholism's physical allergy-like component and the spiritual solution to the obsessive psychological craving coalesced. After that, the rest, as they say, is history. Michel W.
