## **Love In Action**

At my first AA meeting in 1965, I felt embraced by the love in the room right away. People brought coffee, held the cup for me and made me feel special. I was shaking, drunk and unsteady. Although I was 28, I had never experienced anything like this outpouring of good will before.

That first meeting was an hour and a half. Not only did the people there introduce me to a sponsor, they agreed to meet me at an AA meeting closer to my home the next day. People in AA got me to agree to call them if I felt in danger of taking another drink. They made it clear that it didn't matter what time of day I called or when I called, even very late at night.

My family was concerned about my joining AA, as they thought I would infect them with sobriety. I was given some distance and no one in my family would accompany me to a meeting.

Members with long-term sobriety would take me with them on Twelfth Step calls. We were like family. Remember when the phone would ring at our AA meetings, about four or five of us would jump up to answer.

Members even helped me find a job. I got help with medical problems from doctors in my meeting. People helped me when I was dealing with family and housing issues. It seemed there was an AA person who could help me with just about anything. One time, I was in a meeting talking about a crazy car accident I had been in. I was blamed for the accident even though I was innocent. Before I knew it a friendly judge in AA helped me take care of it. Through the years, I have been able to help fellow members move and clean their yards and houses. I've gotten to pitch in, give rides to meetings and take members out to coffee or meals after the meeting, I've especially love helping with weddings, showers and other important events.

My calendar has always been full of events, including AA get-togethers and sober conventions. I've cooked for large AA events and even got to run a race to help a fellow handicapped member. Over the years I've been able to help newcomers in unexpected places, like meetings on cruise ships. One time I was in a long check-in line at the airport reading my Big Book when a man nearby noticed. We had a nice talk, and he thanked me for reminding him to go back to AA.

I am sober 56 years now. Due to my poor health and my need to use a walker I'm ...

Here are the next three promises taken from the <u>list</u> that the Atlanta Men's Workshop found in the Big Book (they found 147.) Please reference the February 2024 *Communique* for the full list of promises that we will be covering:

### Pg Line Promises

- They will always materialize if we work for them.
- 84 31 And we have ceased ... fit spiritual condition.
- 85 27 If we have carefully ... His sprit into us.

We will suddenly realize that God is doing for us what we could not do for ourselves. Are these extravagant promises? We think not. They are being fulfilled among us--sometimes quickly sometimes slowly. They will always materialize if we work for them.

## pg. 84

And we have ceased fighting anything or anyone -- even alcohol ... We will see that our new attitude toward liquor has been given us ... That is the miracle of it. That is how we react so long as we keep in fit spiritual condition.

#### pg. 85

Much has already been said about receiving strength, inspiration and direction from Him who has all knowledge and power.

If we have carefully followed directions, we have begun to sense the flow of His Sprit into us.



## Step 12

Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs.

## **Tradition 12 (Long Form)**

And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.

We need to remember to "practice these principles in all our affairs." That includes social events held by Hernando County Intergroup and District 13. We should be kind and respectful of the venue we are renting.

Recently, at Sand Hill Scout Reservation, where the Gratitude Dinner was held, their 24-hour surveillance cameras witnessed members of our group smoking on their property. Sadly, we are no longer welcome at that facility.

Also noted, people were talking during the readings and speaker time. Let's all remember to respect one another; "Principles Before Personalities." This we owe to each other and the AA Program that saved our lives.

### No Alcoholic Should Find a Locked Door

Hey y'all! My name is Emma and I'm an alcoholic. My sobriety date is July 14, 2022. I am also the current chair for H.E.A.A.R.T. (Hernando Emergency AA Response Team). H.E.A.A.R.T is an Intergroup committee that comes into action whenever our Governor declares a state of emergency. These emergencies can be anything from hurricanes to pandemics. H.E.A.A.R.T. was created to help the members of Hernando County AA be aware of any meetings that are going to be affected by a state of emergency and will need to go down. A little bit of house-keeping before we get into this article. When we talk of meetings that are not going to be held, the proper terminology is "down" not "closed" and "up" not "open." This verbiage is not interchangeable. As most of us know a "closed" meeting is for A.A. members only or for those who have a drinking problem and "have a desire to stop drinking." An "open" meeting is a group meeting that is open to anyone in the community, including non-alcoholics. A meeting that is "down" will not be held at its regularly scheduled time and will be reflected on the meeting finder on the website and the app.

I was asked to be chair of this committee by Nancy E., the previous chair. She gave me plenty of materials and a wonderful base to jump off from. I was excited to take on this commitment. When I first came in, it was during hurricane season. I remember trying to get a meeting in before Idalia was scheduled to hit in August 2022. I got into my truck and wound up at a meeting location with its doors locked. This was a very scary feeling for me at that time. I grew up in Florida. Hurricane parties were normal. Stocking up on liquor was more important to me than water or food. Thankfully, I didn't go out and was able to find an online meeting to help hold me over until the next in person meeting was available. When I took on this commitment, I was determined to never have another alcoholic have that gut wrenching fear hit them; to be full of dread like I was. I was to do my best to carry the message, even during emergencies.

I took what I was given and worked hard to make it my own. I rearranged some documents, deleted others, and edited the verbiage that was used. There weren't many changes that needed to be made, and I felt blessed to be off to a strong start. My Higher Power has a sense of humor and threw me a storm in the middle of December 2023. I tried my best not to be nervous, and I learned a lot from that flooding event. I was able to see gaps in the system of H.E.A.A.R.T. and opportunities to add in some new elements.

In January of 2024 I decided to start incorporating technology into the process. In the past, all committee members were given a paper packet of information. It was strongly suggested that they have them easily accessible in the event of an emergency. I decided to make all of this information available via the internet. With the help of the Technology committee these documents were loaded onto a Google drive and a password protected area was added to the AA website. These documents could now be accessed anywhere that you had your smartphone or computer. This addition has become a great asset for me as I'm not always at home to be able to grab that paper packet. For me, it was great for the environment and also a money saver for Intergroup.

I held my first committee meeting and welcomed Accessibilities to join us. After speaking with the chair and co-chair of that committee we came up with the idea to make a "meeting-in-a-bag." I handed these items out to meeting reps that were located in areas where you may not be able to get out from, but those that lived within that area would still be able to get to each other. A "meeting-in-a-bag" contains a few readings from our literature, a 7th tradition basket, and even some wooden chips for those celebrating a sobriety milestone. Thank you, Diane B. and Laura L.,

for this addition to H.E.A.A.R.T. I was presented another opportunity where H.E.A.A.R.T. could be of assistance. Our beloved Coulton Hall had its electricity go out. I was able to contact the meeting rep and keep all AAs apprised of the situation. Even though this was not considered a state of emergency, this was a perfect situation to use our tools. Remember, my goal was to never have an alcoholic find a locked door. I will go to any lengths to achieve this.

We had our first major event in June, and it went seamlessly. My committee kept me updated on any meetings that were to go down. The Technology chair and I suggested that some select meetings should go down. Only a few decided that was best for their group, and that is okay. Tradition 4 tells us that, "each group is autonomous except in affecting other groups of A.A. as a whole." This committee cannot make a meeting go down. It is solely up to the group conscience. Social media was continuously updated by working closely with the Technology committee. They made sure that the meeting finder of the website was kept up to date. During this time, I learned that we have no direct control over the meeting app that a lot of us use. This app takes information from our website. Sometimes glitches happen. It is always advised to check out our website for the most up to date and correct information.

A few storms came and went without much fan-fare. In late September I had to fly to Chicago due to a death in the family. While up there, Helene was headed toward Florida. I couldn't be in two places at once. Yes, I had the electronic packet with all of pertinent information at my finger-tips, but all of my attention had to remain in Illinois. AA taught me that there are things that are out of my control. Let go and let God is what I did. Through use of the Serenity prayer, I realized that I needed to be fully in Illinois, so I handed over the duties of this storm to my wonderful alt-chair Deborah-Anne C. I had full faith in her and knew she would do an amazing job with keeping everyone apprised as the storm passed over us. She did a wonderful job down here and I was able to be focused where I was needed.

Remember how I said my Higher Power has a sense of humor? Well, Milton was headed straight at us as I was getting off of the plane at the Tampa airport. As soon as I turned my phone on, I went to work speaking with my meeting reps and updating social media. During this storm I decided to not only post individual meetings that were to be down, but to also pin a thread at the top of our social media page to keep a running list going. Several meetings chose to go down out of an abundance of caution. All hands were on deck, and the committee did a fantastic job. This running list also helped the Technology committee keep track of the down meetings so they didn't need to sift through tons of individual social media posts.

As this hurricane season comes to a close, I am looking forward to watching something other than the weather report every day. I want to thank Deborah-Anne C. for stepping up to the plate when I couldn't be here and offering her help during each event. I want to thank Diane B. and Laura L. for using their Accessibilities Committee to help make H.E.A.A.R.T stronger with the addition of a "meeting-in-a-bag." I want to extend a huge shout out to the Technology Committee, John K. and Andrew W. I couldn't do what I do without the two of you. I also want to thank each and every one of you that are meeting or building reps. This is not MY committee; this is OUR committee. You all do a wonderful job. Thank you for your service.


